# Increasing Life Benefit



In the unfortunate event of your death, your beneficiaries will receive the Life Benefit.

The Life Benefit increases by 5% at each Policy Anniversary on a simple straight-line basis until the end of the Policy Term or until a death claim is made.

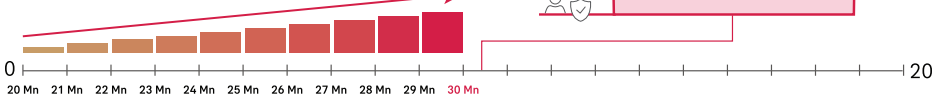

Rs. 20 Mn Life Benefit amount increases by 5% annually (Rs. 1 Mn) and on the 11<sup>th</sup> year, the Life Benefit will be Rs. 30 Mn

# OPTIONAL BENEFITS



## Family Income Benefit (Optional)

If you pass away or become Totally Permanently Disabled (TPD) due to an accident or sickness, your beneficiaries will receive a 'Monthly Income' for the next 5 years.

You can select a monthly income amount your family would require from Rs. 10,000 per month and upwards.

The Family Income Benefit amount at the start of your Policy will increase by 5% at each Policy Anniversary on a simple straight-line basis until the monthly payment becomes payable.

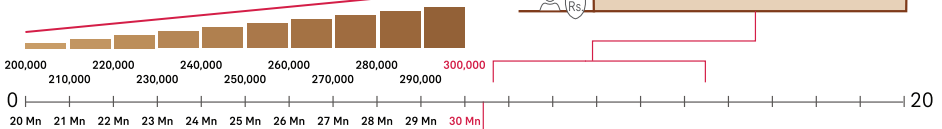

#### INCREASED FAMILY INCOME BENEFIT

Rs. 200,000 FIB amount increases by 5% annually (Rs. 10,000) and on the 11<sup>th</sup> year, the FIB will be Rs. 300,000



**2** Rs. 300,000 will be paid monthly for the next 5 years In addition to the Life Benefit (Rs. 30 Mn) already paid

Rs. 20 Mn Life Benefit amount increases by 5% annually (Rs. 1 Mn) and on the 11<sup>th</sup> year, the Life Benefit will be Rs. 30 Mn



**1** Life Benefit of Rs. 30 Mn will be immediately paid to the beneficiaries





### **Accidental Death Benefit (Optional)**

In the event of unfortunate death due to an accident, the beneficiaries will receive the Accidental Death Benefit amount in addition to the Life Benefit.



### **Permanent Disability Benefit (Optional)**

If you become Totally Permanently Disabled due to an accident or sickness, you will receive the selected benefit amount.

If you become Partially Permanently Disabled due to an accident, you will receive a benefit amount based on the Table of Benefits in your policy document.



### **Premium Protection Benefit (Optional)**

If you become Totally Permanently Disabled due to an accident or sickness, AIA will pay the premiums on your behalf until the end of the Policy Term ensuring your protection.

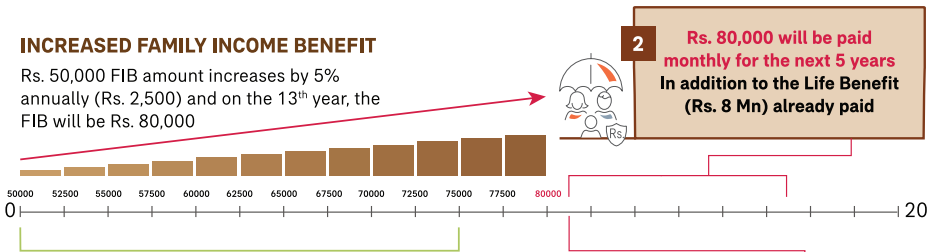

#### INCREASED FAMILY INCOME BENEFIT

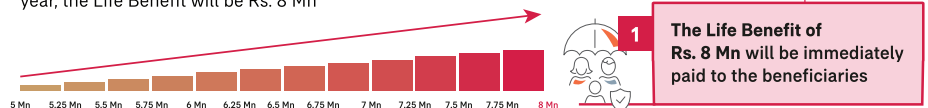

#### INCREASED LIFE BENEFIT

Rs. 5 Mn Life Benefit amount increases by 5% annually (Rs. 250,000) and on the 13<sup>th</sup> year, the Life Benefit will be Rs. 8 Mn

## FREQUENTLY ASKED QUESTIONS

### 1. What is AIA Super Protector Flexi?

AIA Super Protector Flexi is a smart life insurance solution with limited premium paying terms for your PROTECTION needs. It includes optional benefits to provide you with a more comprehensive coverage solution.

### 2. Do I have to pay premiums throughout the entire Policy Term?

AIA Super Protector Flexi is a Limited Pay life insurance solution. You can select from 3 options according to your needs. The following are the Premium Paying Terms and Policy Terms of AIA Super Protector Flexi.

### **3. What does AIA Super Protector Flexi cover me for?**

AIA Super Protector Flexi comes with a Life Insurance Benefit along with four optional benefits that you can use to personalize the policy according to your requirement. The four optional benefits are as below;

- a) Accidental Death Benefit
- b) Permanent Disability Benefit
- c) Family Income Benefit
- d) Premium Protection Benefit

### **4. I already have savings – why do I need this?**

The environment around us can be uncertain, resulting in many unexpected situations that may arise during our lives. In the event of a disease or an accident, you and your loved ones will require adequate financial protection. In the absence of a Life Insurance plan, you will have to use your hard-earned savings. Therefore, owning a personalised financial protection solution is vital for any of us. AIA Super Protector Flexi is one of the best life insurance plans in Sri Lanka and is equipped to financially protect you and your family when you need it the most.

### **5. Is it possible to receive an Accidental Death Benefit along with the Life Insurance Benefit?**

Yes. You can add the Accidental Death Benefit to your Policy. In the event of an unfortunate death due to an accident, your beneficiaries will receive the Accidental Death Benefit amount in addition to the Life Benefit.

### **6. Does the 5% increase of the Life Benefit continue until the end of the Policy Term?**

Yes. The increase of the Life Benefit by 5% at each Policy Anniversary on a simple straight-line basis will continue until the end of the Policy Term or until a death claim is made. In the unfortunate event of a death, the total Life Benefit which includes the increase will be immediately paid to your beneficiaries.

### **7. When can I claim the Permanent Disability Benefit?**

If you become Totally Permanently Disabled due to an accident or sickness, you will receive the selected benefit amount. However, the Permanent Partial Disability Benefit will be paid when Permanent Partial Disability occurs due to an accident only. You will receive the benefit amount based on the table of benefits specified in the policy document.

**8. If I am planning on going abroad for studies or work, can I obtain AIA Super Protector Flexi and claim benefits for any requirements that arise while I am abroad?**

Yes. You can obtain a policy if you are a Sri Lankan citizen residing in Sri Lanka at the time of purchasing the policy. However, the benefits of the policy will be paid in Sri Lankan Rupees. You need to tell us of your intention to travel outside of the country for a long period of time, before you travel.

**9. What would happen if I pass away during the Policy Term?**

- a) Your beneficiaries will receive the increased Life Benefit value immediately.
- b) If you have opted for the Family Income Benefit, your beneficiaries will receive the increased 'Monthly Income' for the next 5 years.

**10. What would happen if I become totally permanently disabled and have selected the Family Income Benefit along with the Premium Protection Benefit?**

- a) The Permanent Disability Benefit will immediately be paid to you.
- b) You will receive the increased 'Monthly Income' for the next 5 years.
- c) AIA will pay the premium on your behalf for the rest of the Policy Term.
